- Prayers for the canonization of Ozanam and for the Board members of the CGI
- 2. Keep the unity within SSVP
- Always be very generous in the collections, donations, appeals and campaigns developed by the General Council



- 1. Have a full spiritual life, with the effective participation in the Holy Mass and in the sacraments
- Participate actively in the Vincentian events, promoted by the Conferences and the Councils
- Give more space for young people, demonstrating commitment to the renewal of our Society
- 4. Faithful to the SSVP Rule, even with all the imperfections contained therein



- 5. Avoid conflicts and vanity, because these feelings keep us from God
- 6. Promote the values of the family and the Gospel, especially at the time of the home visit
- 7. Focus your energies on what really matters: the promotion of the most needy and our personal sanctification. Do not waste time!
